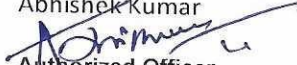

Shahpur SHO Santosh Kumar Singh said police have launched an investigation to identify and trace the driver of the vehicle involved in the accident.

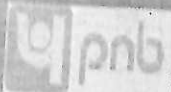
