Mr. Sk Nurul Huda availed Cash Credit facility from Indian Bank, Sukur Branch the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Sk Nurul Huda** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 17.04.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) liable to the Bank to pay the amount due to the tune of **Rs.13,61,324.00 (Rupees Thirteen Lakh Sixty One Thousand Three Hundred Twenty Four Only)** as on 17.04.2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 17.04.2026.

As **Mr. Sk Nurul Huda** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 07.07.2026 after complying with all legal formalities.

As per Rule 8(6) of the Security Interest (Enforcement) Rules 2002, framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.
