Mr. Dinesh Hanumant Idate & Mrs. Prachi Dinesh Idate to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
