As M/S Tube Forged, Mr. Arindam Hazra, Mrs. Rina Hazra, Late Mr. Ramendra Nath Hazra (since deceased), Partner of M/s Tube Forged, represented by his legal heirs Mr. Hara Kumar Hazra & Mr. Raj Kumar Hazra (brothers) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 23.07.2026 after complying with all legal formalities.

The amount due as on 17.08.2026 is of **Rs. 22,44,285.00 i.e. Rupees Twenty-two Lacs Forty-four Thousand Two hundred and Eighty-five only** with further interest, costs, other charges and expenses thereon from 18.08.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

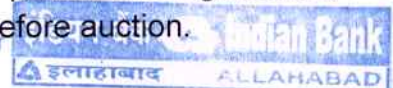
The date of sale is fixed as 25.09.2026 Time 11:00 AM which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from 10.09.2026 to 24.09.2026 between **10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
