Whereas the undersigned being the Authorized Officer of the Bank of Baroda u/s 13(2) of the above said SARFAESI Act, 2002 and in exercise of the powers conferred u/s 13(2) of the said Act read with Rule 3 issued a Demand Notice on **06-01-2025** calling upon the Borrower(s)/Guarantor(s)/Corporate Guarantor(s) of **M/s. S K Jha Infrastructure Pvt Ltd. (Borrower), Mr. Sushil Jha (Guarantor), Mrs. Prabha Jha (Guarantor), M/s. 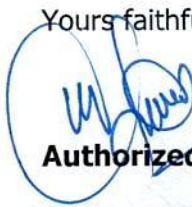
