1. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Chalan from the website (<https://baanknet.com>) for **depositing in bidders e-Wallet**. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**. 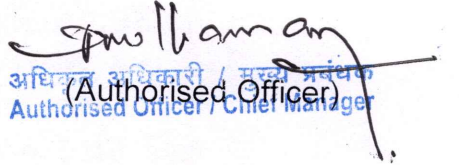
