The intending bidders/purchasers are further required to upload their KYC documents and Bank details. Registration and uploading formalities should be completed well in advance.
2. EMD Payment: The intending Bidders/Purchasers are requested to register on portal (<https://ebktray.in>) using their email-id and mobile number. The process of e-KYC is to be done through Digilocker and after completion of KYC verification; the intending bidders/Purchasers may login and make the EMD payment.
