M/s. A. S. Traders (Prop: Mr. Shahrukh) – 6825978194 of our Khalilabad Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s. A. S. Traders (Prop: Mr. Shahrukh) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 17.04.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) M/s. A. S. Traders (Prop: Mr. Shahrukh), Address: Motinagar, Khalilabad, Dist-Sant Kabir Nagar – 272175, Mr. Shahrukh S/o- Mohd. Mustafa (Proprietor of M/s. A. S. Traders), Address: Madya Khas, Khalilabad Dist- Sant Kabir Nagar-272175, Mrs. Taribunnisha W/o- Mohd. Mustafa (Guarantor & Mortgagor) Address: Madya Khas, Khalilabad, Dist- Sant Kabir Nagar-272175, liable to the Bank to pay the amount due to the tune of Rs. 8354175/- (Rupees Eighty Three Lakh Fifty Four Thousand One Hundred Seventy Five Only) as on 17.04.2026 with further interest, costs, other charges and expenses thereon. He failed to make payment despite Demand Notice dated 17.04.2026.

As M/s. A. S. Traders (Prop: Mr. Shahrukh), Mr. Shahrukh S/o- Mohd. Mustafa (Proprietor of M/s. A. S. Traders) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 01.07.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

\*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 08.09.2026 is Rs. 8965891.00 (Rupees Eighty Nine Lakh Sixty Five Thousand Eight Hundred Ninety One Only) with further interest, costs, other charges and expenses thereon from 09.09.2026.



Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as **30.09.2026** which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
