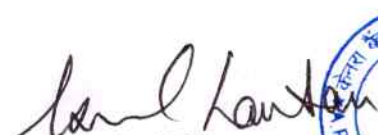

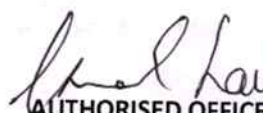

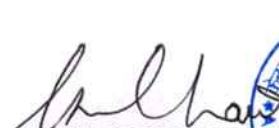
- subject to approval by the Authorized Officer/Secured Creditor.

- i. Sale shall be confirmed in favour of the successful bidder, subject to confirmation of the same by the secured creditor.
