

SC allows HP to withdraw prosecution against sitting, ex-MLAs in several cases

THE SUPREME Court on Wednesday allowed the Himachal Pradesh government to withdraw prosecution against some sitting or former MLAs in several criminal cases registered during the pandemic.

A bench of Chief Justice Surya Kant and Justices Joy-malya Bagchi and V Mohana noted that no grave or heinous crimes were alleged in these cases, which included those related to burning of effigies and 'dharnas' on highways.

The top court's order came while hearing a plea filed by the state government challenging a April 2024 order of the Himachal Pradesh High Court.

The high court had passed the order on an application filed by the state in 2023 seeking its permission to withdraw the prosecution in 65 cases against sitting or former MLAs on the basis of instructions issued by the home department in December 2022. The high court had partly allowed the state's plea and permitted withdrawal of 15 cases. The state then moved the apex court challenging the high court order.

On Wednesday, the counsel appearing for the state said they had sought the high court's permission to withdraw the prosecution in these cases.

"There is nothing serious in these cases. There was no damage to public property and there was no injury caused," the

counsel said. The top court noted that in the application filed before the high court, 65 cases were mentioned, out of which five were disposed of while the matter was pending there. It said the high court permitted withdrawal of 15 cases and out of the remaining 45 cases, four cases resulted in acquittal or discharge.

The bench observed that incidents alleged in these cases

pertain to the period of the pandemic which was an exceptional situation where people, including public representatives, were in distress in different manners. It said none of these cases shows any grave or heinous crime. While allowing the appeal filed by Himachal Pradesh, the bench modified the high court order and allowed the state to withdraw prosecution in these cases.

Centre agrees to fund construction of heliports under UDAN scheme

UNION CIVIL Aviation Minister Kinjarapu Rammohan Naidu has directed authorities to finalise the techno-economic feasibility report for the expansion of Kangra Airport within two months.

The Centre has also agreed to provide funding for the construction of heliports in the hill state under the UDAN scheme.

Himachal Pradesh Chief Minister Sukhvinder Singh Sukhu met Naidu in New Delhi on Wednesday and held detailed discussions on various issues related to strengthening air connectivity and expanding aviation infrastructure in the state, a statement issued here said. Taking up the expansion of Kangra Airport on priority, the CM highlighted its importance for tourism development in the state, noting that tourism plays a significant role in the state's economy and that improved air connectivity would facilitate tourist movement and further boost tourism activities.

He informed the Union Minister that the land acquisition process for the expansion of Kangra Airport has already been completed.

The Union Minister directed the authorities to finalise the techno-economic feasibility report for the expansion of Kangra Airport within two months. He also directed officials to appoint a competent

consultant for the project and ensure that the report is finalised within the stipulated time-frame, the statement added.

The chief minister said if the techno-economic feasibility report is finalised within two months, the expansion process of Kangra Airport would gain momentum and the project could move forward faster. He also urged the Airports Authority of India (AAI) to undertake a realistic assessment of the project cost.

The CM also raised the issue of developing heliports in various parts of the state, considering Himachal Pradesh's difficult geographical terrain.

2 from Haryana, Punjab die at Manimahesh trek

ONE PERSON each from Haryana and Punjab died during the ongoing Manimahesh Yatra in Chamba district in the past 24 hours, with officials attributing the deaths to sudden health complications.

According to the district administration, a 55-year-old pilgrim Manmohan Lal from Fatehgarh in Ambala district of Haryana died on Tuesday after his health deteriorated during the pilgrimage. He was provided immediate medical assistance, but could not be saved despite doctors' efforts. People accompanying him said he had a history of heart treatment and had undergone stent placement.

A district administration official said, "Victim Lal and his colleagues reached at Gauri Kund from Bharmour in chopper. They trekked from Gauri Kund to Dal Lake, Manimahesh. The body has been handed over to the victim's friends as per the wish of victim's family members."

Meanwhile, a 51-year-old Sucha Singh, a resident of Pathankot in Punjab, died while serving at a community kitchen (langar) at Gauri Kund on Wednesday. His health reportedly deteriorated suddenly before he died. The exact cause of death has not yet been confirmed. Officials said the cause would be established after post-mortem examination once the body is brought down from Gauri Kund.

Following the two deaths, Bharmour Additional District Magistrate Vikas Sharma urged pilgrims to undergo a proper health check-up before undertaking the pilgrimage.
