3. The Vehicle will be sold over & above the Reserve Price fixed by the Bank and minimum increment over the reserve price shall be Rs.50000/-(Rupees Fifty Thousand Only) for each asset.

4. The intending bidders shall deposit Earnest Money Deposit (EMD) of Rs.6,50,000/-(Rupees Six Lakhs Fifty Thousand Only) being 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" well before 28/09/2026 upto 10:00 AM.
