M/s Ishika Enterprises (Proprietor-Mr Diwakar Singh) availed GSS CC-PMEGP (AGRL) facility from Indian Bank, Modinagar Station Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties" M/s Ishika Enterprises (Proprietor-Mr Diwakar Singh) failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 22.03.2023 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), M/s Ishika Enterprises and Proprietor/Guarantor/Mortgagor-Mr Diwakar Singh liable to the Bank to pay the amount due to the tune of Rs. 13,48,807/- (Rupees Thirteen lakhs Fourty Eight Thousand Eight Hundred Seven Only) as on 22.03.2023 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 22.03.2023.

As M/s Ishika Enterprises failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 24.11.2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 30 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 12.08.2026 is Rs. 19,53,812/- (Rupees Nineteen Lakh Fifty Three Thousands Eight Hundred Twelve Only) with further interest, costs, other charges and expenses thereon from 12.08.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/ Authorized Officer any time after 30 days.
