TERMS & CONDITIONS OF E-AUCTION.

Terms & Conditions

(a) The Bidders should get themselves registered on <http://baanknet.com> by providing requisite KYC documents and registration fee as per the practice followed by M/s ebkay Ltd well before the auction date (The registration process is detailed on the above website)

(b) The intending bidders should transfer his EMD amount by means of Challan generated on his bidder account maintained with ebkay LTD at <http://baanknet.com> by means of NEFT/RTGS transfer from his bank account.

(c) The intending bidders should take care that the EMD is transferred at least One day before the date of auction and confirm that his wallet maintained with M/s ebkay Limited is reflecting the EMD amount without which the system will not allow the bidders to participate in the e-auction.

(d) The EMD of the successful bidders will be automatically transferred to the bank once the sale is confirmed by the respective Authorised Officer of the bank and the remaining amount i.e 25% of the sale price to be paid immediately i.e on the same day or not later than the next working day as the case may be. In case of default in repayment the sale will be cancelled and the amount already paid will be forfeited.

(e) During e-Auction, if no bid is received within the specified time, State Bank of India at its discretion may decide to revise opening price / scrap the e-Auction process / Proceed with conventional mode of Tendering.

(f) The Bank / service provider for e-Auction shall not have any liability towards bidders for any interruption or delay in access to the site irrespective of the causes. The Bidder are required to submit acceptance of the Terms and conditions and modalities of e-Auction adopted by the service provider, before participating in the e-Auction.

(g) The bid once submitted by the bidders, cannot be cancelled / withdrawn and the bidder shall be bound to buy the property at the final bid price. The failure on the part of bidders to comply with any of the terms and conditions of e-Auction, mentioned herein will result in forfeiture of the amount paid by the defaulting bidders.
