Sub: Your Home Loan account No.6841543549 and Ind Kavach Home Loan account No.7053478087 with Indian Bank Vasudevanallur Branch – Reg.

Mr. G. Murugan and Mrs. M. Mahesh availed Home Loan No.6841543549 and Ind Kavach Home Loan No.7053478087 facilities with Indian Bank, Vasudevanallur Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as the 'the Properties'. Mr. G. Murugan and Mrs. M. Mahesh failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 17.06.2022 under Sec.13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as 'The Act'), was issued by the Authorized Officer calling upon Borrower (s), Guarantor (s), 1. Mr. G. Murugan S/o. Mr. Gurusamy and 2. Mrs. M. Mahesh W/o. Mr. G. Murugan liable to the Bank to pay the amount due to the tune of Rs.11,30,502/- (Rupees Eleven Lakhs Thirty Thousand Five Hundred and Two only) as on 15.06.2022 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 17.06.2022

As Mr. G. Murugan and Mrs. M. Mahesh failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 16.09.2022 after complying with all legal formalities.

As per Sec.13(4) of the Act, Secured creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance, in accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6(2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended Sale is required to be given and hence we are issuing this notice.

The amount due as on 08.09.2026 is **Rs.18,42,150/- (Rupees Eighteen Lakhs Forty Two Thousand one Hundred and Fifty only)** with further interest, costs, other charges and expenses thereon from 08.09.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned / Authorized Officer any time after 15 days.

The date of sale is fixed as 25.09.2026 which would be by e-auction mode.
