Mrs. Smita Sachin Shelke have availed Loan facility from Indian Bank, Pimpri Chinchwad Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs. Smita Sachin Shelke have failed to pay the outstanding dues to the Bank. Both failed to make payment despite Demand Notice dated 16.11.2023.

As you have failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 15/05/2024 and physical possession taken on 03.06.2026 after complying with all legal formalities.

The amount due as on 31.08.2026 is **Rs. 40,16,400/- (Rupees Forty Lakhs Sixteen Thousand Four Hundred Only)** with further interest, costs, other charges and expenses thereon from 01.09.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 25.09.2026 which would be by e-auction mode.
