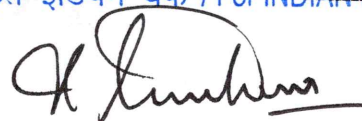

M/s. Bridgeview Ships and Ports Private Limited availed Term Loan facility from Indian Bank, CBD Belapur the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s. Bridgeview Ships and Ports Private Limited failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 06.06.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) M/s. Bridgeview Ships and Ports Private Limited (Borrower), Mr. Vivek Anand (Guarantor), Ms. Neetu Rashmi (Guarantor), Mr. Arvind Kumar Agarwal

(Guarantor/Mortgagor), Ms. Seema Agarwal (Guarantor/Mortgagor), M/s. Bridgeview Maritime Pvt Ltd (Guarantor) liable to the Bank to pay the amount due to the tune of Rs. 4,34,01,831/- (Rupees Four Crores Thirty Four Lakhs One Thousand Eight Hundred and Thirty one Only) as per demand notice dated 06.06.2026 with total amount of Rs. 4,53,65,894/- (Rupees Four Crores Fifty Three Lakhs Sixty Five thousand Eight Hundred and Ninety Four Only) as on 17.09.2026 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notices dated 06.06.2026.

As M/s. Bridgeview Ships and Ports Private Limited failed to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act on 14.08.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days-notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 17.09.2026 is Rs. 4,53,65,894/- (Rupees Four Crores Fifty Three Lakhs Sixty Five thousand Eight Hundred and Ninety Four Only) with further interest, costs, other charges and expenses thereon from 18.09.2026

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 28.10.2026 which would be by e-auction mode.

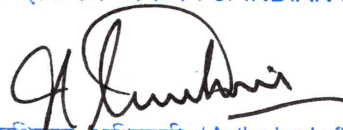
The sale is subject to confirmation by the Secured Creditor.

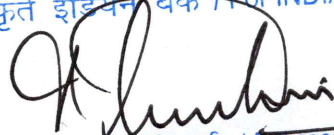
