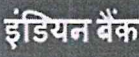

Sub: Your loan account/s 7806932063 (Home Loan) with Indian Bank (Nanapeth) – Reg.

Mr.Prashant Kumar Kulkarni (Borrower and Mortgagor)and others had availed Home Loan facilities and facilities mentioned above from Indian Bank, Nanapeth Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.Prashant Kumar Kulkarni (Borrower and Mortgagor)and others and others had failed to pay the outstanding dues to the Bank.
