Mrs. Shesh Deshmukh and Mr. Sanjay Deshmukh availed Housing loan facility from Indian Bank, **Durg Ganjpara** Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mrs. Shesh Deshmukh and Mr. Sanjay Deshmukh** failed to pay the outstanding dues to the Bank.
