JUDGE DEALS BLOW TO TRUMP MOVES TO DEPORT PRO-PALESTINIAN ACTIVISTS

California, Aug. 29: A federal judge on Friday ruled that laws that President Donald Trump's administration used to cancel visas and initiate deportation proceedings against non-citizen college students based on their pro-Palestinian advocacy and criticism of Israel are unconstitutional.

US District Judge Noel Wise in San Jose, California in a blistering ruling chastised the state department and department of homeland security for how they had deployed provisions of federal immigration law to target non-citizens for deportation for expressing views they wanted to suppress. — Reuters
