

Congress Agitation Ends in Kekri After Seven-Day Deadline

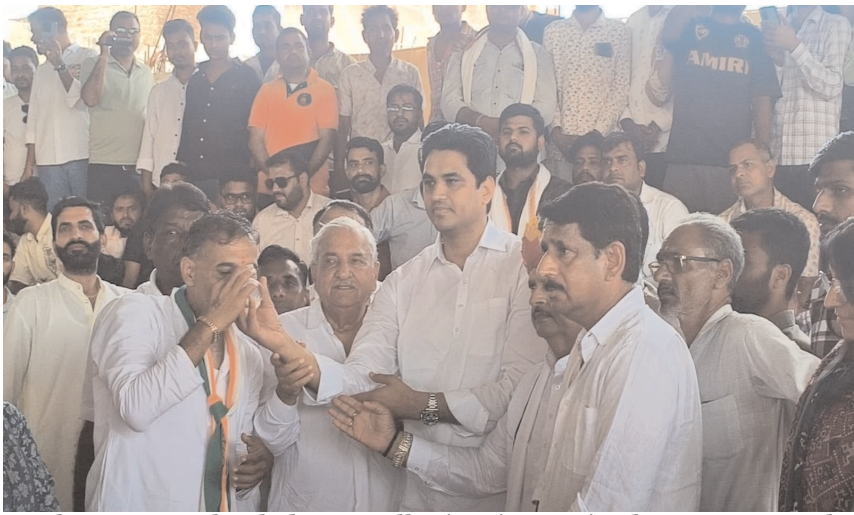
Leaders warn of intensified protest if demands remain unresolved; Kekri shutdown receives mixed response

KEKRI (Deepankur Chouhan): The Congress agitation over a room being used as the MLA's public grievance centre at the Kekri Municipal Council premises ended on Wednesday after the administration was given seven days to address the party's demands.

Kekri Municipal Council Chairman Anil Mittal, along with Congress councillors and party workers, had staged a protest demanding that the room be vacated, claiming that it was designated as the chairman's chamber.

Congress leaders said the administration has been given seven days to resolve the issue and warned that the agitation would be intensified if the demands are not addressed within the stipulated period.



The protest also led to a call for a Kekri bandh by Anil Mittal over the continued locking of the room. Congress workers visited various markets and appealed to shopkeepers to support the shutdown. Several shops remained closed in the morning, but many reopened later, resulting in a mixed response to the bandh.

Congress supporters and residents from different villages of the assembly constituency also reached the Municipal Council premises in support of the protest. Following the decision to give the administration seven

days, the Congress called off the dharna for the time being. Later, former Rajasthan Cabinet Minister Dr Raghu Sharma and MLA Vikas Chaudhary offered juice to Municipal Council Chairman Anil Mittal, bringing his hunger strike to an end.

The Congress maintains that the room currently being used as the public grievance centre is the designated chamber of the Municipal Council chairman. BJP MLA Shatrughan Gautam, however, has presented a different position regarding the building and its previous use.

Ajmer Dairy Chairman Ramchandra Choudhary, Shailendra Singh Shaktawat, City Congress President Hemant Jain, Seema Choudhary, Ratan Panwar and Mukesh Jain, along with Congress councillors, office-bearers and workers, were present during the protest.

Your city will hold you back." This is a phrase that almost every dreaming young person living in India's small towns often hears. Today, Abhishek Vyas, founder and CEO of My Haul Store, is counted among the

country's successful young entrepreneurs, but this position was not served to him on a platter. Behind this success lies the bitter experience of 9 failed businesses and years of hard struggle. In 2020, when the whole country was battling the crisis of the global pandemic, Abhishek took a risk that changed everything. At that time, he had only ?7,000 left in his bank account, and he borrowed ?1.82 lakh to start the business. On paper, it was the worst time to start a business, but his far-sightedness proved it to be the right decision.

Abhishek recognized a truth that big-city marketing agencies were completely ignoring. He saw that India is not limited to metro cities like Delhi, Mumbai,

or Bengaluru. Here, language, culture, and people's preferences change every 50 kilometers. Instead of chasing a few famous faces in metro cities, he bet on regional creators spread across more than 10,000 pin codes in the country. The result is that today My Haul Store has become a huge network of more than 1,00,000 regional influencers, with more than 1,500 giant brands like Amazon, Myntra, and Mamaearth associated with it.

Even after reaching this height of success, Abhishek did not forget his roots. He felt that first-generation founders coming from small towns (Tier-2 and Tier-3) have no one to guide them or raise their voice. To fill this gap, he started highly popular

podcasts like The Founders Dream and The Powerful Humans, so that any young person dreaming while sitting in Bhilwara, Jodhpur, or Indore does not feel alone in this fight.

Abhishek firmly believes that his journey is not the result of a degree from a big college, family influence, or huge funding, but is living proof that the right strategy and continuous effort always outweigh privileges. His goal is not to increase the valuation of a company, but to create new employment opportunities for 1,000 people. This journey, which started from the streets of Bhilwara, is today giving courage to every young person in the country that where you were born can never decide how high you will fly.

Pakistan must take credible action on crossborder terror before world believes it: MEA

New Delhi, Agency: Pakistan needs to take credible action against cross-border terrorism before the world can believe what it says, the ministry of external affairs said on Tuesday, while hitting out at Islamabad over its claims regarding a recent decision by the Permanent Court of Arbitration. MEA spokesperson Randhir Jaiswal accused Pakistan of "misrepresenting facts" and spreading "falsehoods" as part of its propaganda. Pakistan has a habit of misrepresenting facts and propagating falsehoods to serve its malicious propaganda," Jaiswal said. For starters, the so-called ruling is not a ruling by the Permanent Court of Arbitration, as sought to be projected by the Pakistan minister. It is a ruling by an illegally constituted court. We see this as just one more attempt by Pakistan at distorting the reality," he added. Jaiswal was responding to a question about Pakistan circulating a letter to the president of the UN Security Council regarding recent rulings related to the Permanent Court of Arbitration. His comments also came days after Pakistan increased the reward for information leading to the arrest or conviction of Jaish-e-Mohammed (JeM) chief Masood Azhar. India had last week described Pakistan's PKR 70 lakh reward for information on Azhar as a "phoney" move and asked Islamabad to take concrete action against the JeM chief.

Banks brace for 5-day disruption from September 26; SBI, Indian Bank issue advisories

New Delhi, Agency: Ahead of a three-day nationwide strike by bank unions in support of their demand for a five-day work week and withdrawal of the Performance Linked Incentive (PLI) scheme, public sector undertakings State Bank of India (SBI) and Indian Bank have issued advisories asking customers to complete important transactions in advance. Since September 26 is the fourth Saturday, which is a bank holiday, and September 27 a Sunday, physical banking services would be practically shut for five consecutive days in a row. "Dear Customer, Certain bank employees' unions have called for a 3-day

strike from September 28 to 30. Please complete important transactions in advance. Use ATMs/ADWMs, CSPs, YONO, Internet/Mobile Banking, UPI and other digital channels," SBI said in a statement issued to customers on Tuesday evening. Indian Bank also alerted customers, saying: "Due to proposed banking strike (28-30 Sept'26), banking services may be affected. Please use Mobile Banking, channels.
