Raghavulu condemns Modi's 'U.S.-friendly' foreign policy

Condemning the imposition of 100% tariffs by the U.S. on countries buying Russian oil and gas, CPI(M) Polit Bureau member B.V. Raghavulu said on Saturday that Prime Minister Narendra Modi's U.S.-friendly foreign policy portended serious consequences for the Indian economy. "Mr. Modi should be pragmatic in his approach to the looming crisis. He should ensure that India met its requirement without much dependence on the U.S.," Mr. Raghavulu demanded.

Seven killed in two separate road accidents in Hyderabad

Seven people were killed in two separate road accidents on the outskirts of Hyderabad in the early hours of Saturday. In the first accident, four members of a family returning after Ganesh immersion were killed after their vehicle went out of control on NH-44, and crashed into a bridge, the police said. Hours earlier, three workers were killed after a truck rammed their stationary goods vehicle on the Outer Ring Road while they were trying to replace a flat tyre.

Minister lauds role of private institutions in education

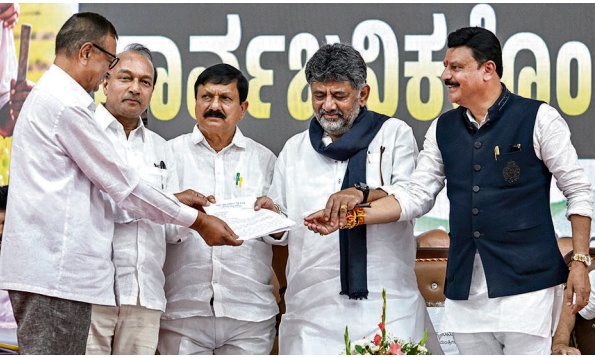

Shivakumar said he would stand by the farming community. He directed the Forest Department not to issue eviction notices to traditional cultivators citing forest encroachment. During a public consultation on the K. Kasturirangan report on Saturday, Mr. Shivakumar said he understands the problems faced by the people in the Malnad region. He told the

not be disturbed," he said. During the meeting, he also assured that his government would pass a resolution urging the Centre to reduce the 75-year requirement to 25 years for claiming land under the Forest Rights Act (FRA).

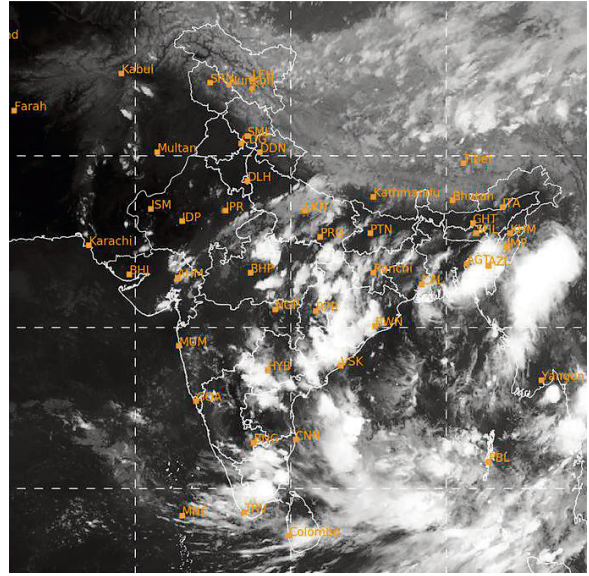
