

PUBLIC NOTICE / PUBLIC AUCTION NOTICE

NOTICE IS HEREBY GIVEN TO THE GENERAL PUBLIC BY Sri. T S Ramachandra Rao, S/o. Srinivasa Rao, aged about 61 years, Residing at N.No.60/29, Ground Floor, 1st Main Road, Lower Palace, Vaivaykalu Ground, Sadashivanagara, Bangalore North, Bangalore, as under:

1. The property described in the Schedule below (initially belonging to Sri. Veerappaiah S/o Nanjundiah and subsequently falling to the share of Sri. T V Eshwariah S/o Late Veerappaiah via a court judgment and decree) is under a legally binding contract. Sri. T V Eshwariah along with his family members had executed a registered General Power of Attorney (GPA) in favour of **Sri. T E Lingarajaya** (S/o TV Eshwariah, R/o Sri Veerappa Rao, 1st Cross, Basavanagudi Extension, Near Vinayaka Park, Shivamogga), registered as Document No. 00050/23-24 on 11.05.2023.

2. Sri. T S Ramachandra, along with two other parties (M/s Royal Monark Group of Co. represented by its partners Sri. Shrinath Sharma and Sri. Jaabir S M), entered into a **Registered Sale Agreement dated 22.12.2025** with the said GPA Holder, Sri. T E Lingarajaya, to purchase the Schedule Properties.

3. The other co-purchasers (Sri. Shrinath Sharma and Sri. Jaabir S M) failed to fulfill their financial obligations, and the cheques issued by them towards the sale consideration were dishonoured. Consequently, their rights under the agreement stand extinguished. I, Sri. T S Ramachandra Rao, having already paid my portion of the advance amount which was duly encashed, am fully ready, willing, and prepared to pay the entire balance sale consideration solely to the owner/GPA holder to complete the registered sale deed conveyance in my independent capacity.

4. To protect my legal rights and enforce the contract, I have already initiated a **Civil Suit before the Hon'ble 2nd Addl. Senior Civil Judge and JMFC at Shivamogga in O.S. No. 247/2026** for specific performance of the contract. In the said suit, the Hon'ble Court has been pleased to pass an **Interim Order of Temporary Injunction restraining Sri. T E Lingarajaya and others from alienating, selling, or creating any third-party interest or encumbrance over the Schedule Properties.** The said injunction order is currently valid, active, and operating.

5. In light of the subsisting and valid Registered Sale Agreement dated 22.12.2025 along with the operating **Temporary Injunction Order passed in O.S. No. 247/2026**, the general public, financial institutions, banks, developers, housing societies, and individuals are hereby strictly cautioned **NOT to enter into any transaction**—including purchase, sale, lease, mortgage, gift, joint development, or creation of any third-party encumbrance/interest—with Sri. T E Lingarajaya, Sri. T V Eshwariah, M/s Royal Monark Group of Co., or anyone claiming through them regarding the Schedule Properties.

6. Any individual or entity dealing with the Schedule Properties despite this notice and the court order will be doing so **strictly at their own peril, cost, and consequences.** Any such transaction will be void, illegal, non-binding, and will amount to a direct violation of the Hon'ble Court's injunction order, inviting severe civil and criminal legal action against such wrongdoers.
