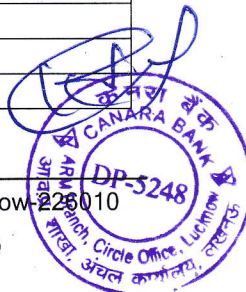

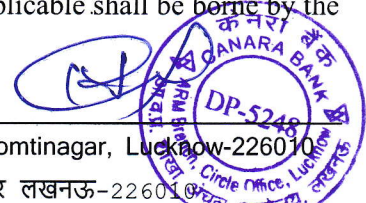
11. Other terms and conditions:
