This is without prejudice to any other rights available to the Bank under the subject Act/ or any other law in force.

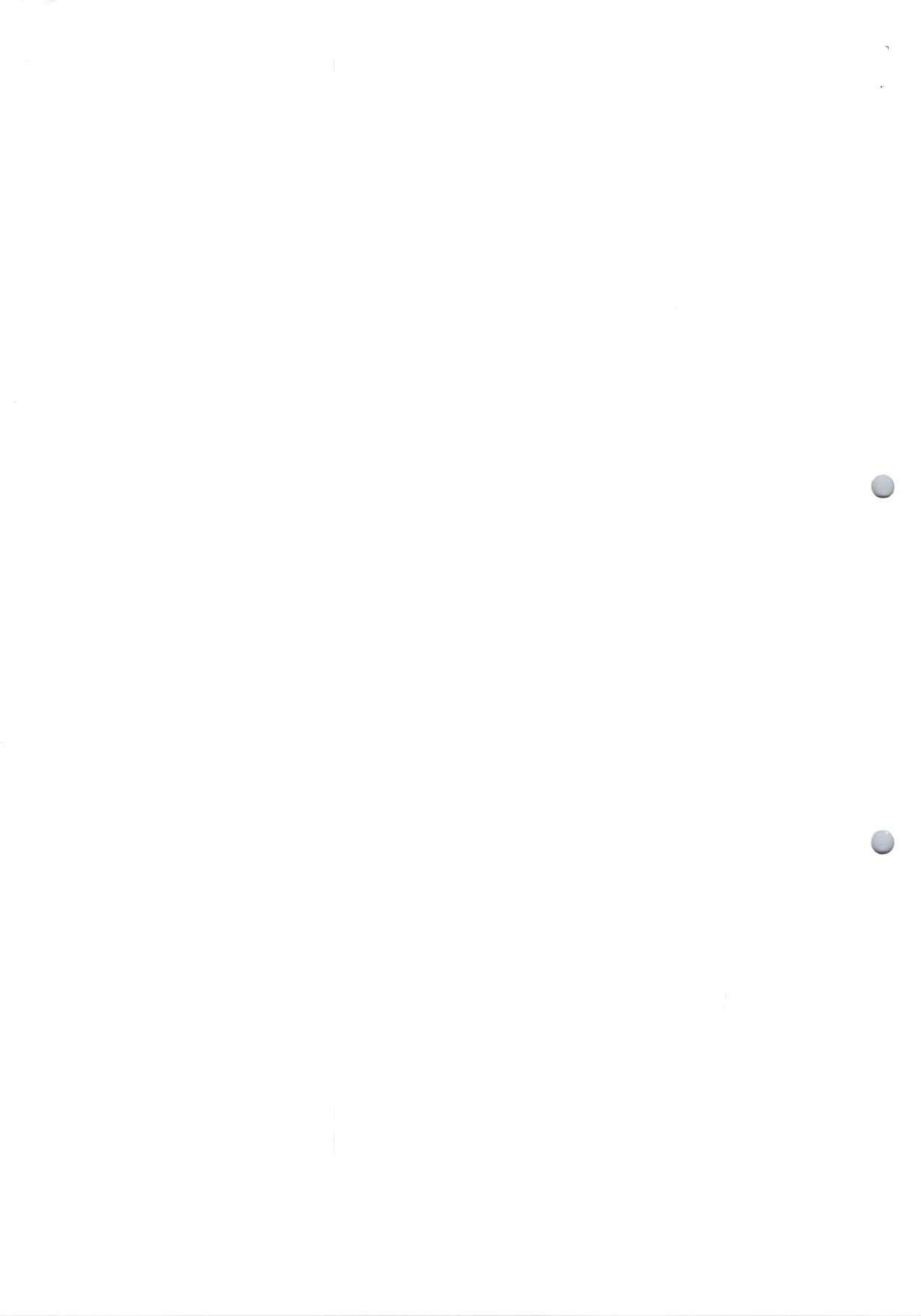

- e) **The intending bidders shall deposit Earnest Money Deposit (EMD) of Rs. 2,95,000/- (Rupees Two Lacs Ninety Five Thousand Only) being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly (online) or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan on or before 16.10.2026 upto 5:00PM .**
